B104's "GEORGE STRAIT FLYAWAY" CONTEST OFFICIAL RULES

A complete copy of these rules can be obtained by contacting radio station WBWN-FM ("Station"), 236 Greenwood Ave., Bloomington, IL 61704, during available business hours Monday through Friday, on the Station website www.wbwn.com, or by sending a self-addressed, stamped envelope to the above address.

The Station will conduct the **B104's "George Strait Flyaway"** Contest (the "Contest") substantially as described in these rules, and by participating, each entrant agrees as follows:

- 1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.
- Eligibility. This Contest is open only to legal U.S. residents, excluding Florida and New York 2. residents, age twenty-one (21) years or older at the time of entry with a valid Social Security number and who reside in the following Illinois counties: Peoria, Woodford, Tazewell, Livingston, McLean, Logan, DeWitt, or Piatt, who have not won a prize from the Station in the last 14 days or a prize valued at \$500 or more in the last 90 days, and whose immediate family members or household members have not won a prize from the Station valued at \$500 or more in the last 90 days. Void where prohibited by law. The term "immediate family members" includes spouses, parents and stepparents, siblings and step-siblings, and children and stepchildren. The term "household members" refers to people who share the same residence at least three (3) months out of the year. The Contest is subject to all applicable federal, state and local laws and regulations. Participation constitutes entrant's full and unconditional agreement to these Official Rules and Station's decisions, which are final and binding in all matters related to the Contest. Winning a prize is contingent upon fulfilling all requirements set forth herein.
- 3. Contest Period. The Contest entry period will begin at 6:30am CT on October 11, 2021 and will run weekdays from 6:30am until 8:50am through 8:50am CT on October 28, 2021 (the "Contest Period"). The Station's computer is the official time keeping device for this Contest.
- 4. **How to Enter.**
 - On-Air: Listen to the Station weekdays at approximately 6:40am, 7:40am, and 9:40 am CT during the Contest Period. When the Station plays the "cue-to-call" sounder, listeners must call the Station at 309-821-1041. Caller nine (9) to the Station, as determined by the Station in its sole discretion, will win a Prize (as defined below) and will be entered for a chance to win the Grand Prize (as defined below) (each a "Qualifier"). There will be up to forty-two (42) Qualifiers. Time Delay Between Over-the-Air Analog Signal and Internet Broadcast: Due to the time delay that exists between the Station's analog over-the-air signal and the Station's online webcast, listeners who listen to the Station online may hear the cue to call later than listeners listening to the Station's analog over-the-air signal. As a result, the odds of an online listener entering this Contest on-air may be diminished.
- 5. **Winner Selection.** On or about 7:40am CT on October 29, 2021, Station will select one (1) potential winner in a random drawing from among all Qualifiers. The selected Qualifier will have ten minutes and forty-one seconds (10:41) to call the Station at 309-821-1041 to be awarded the Grand Prize. If the selected Qualifier does not call the Station within the allotted time, the Qualifier is immediately disqualified, and Station will select another Qualifier. Station will continue to select Qualifiers until the selected Qualifier calls the Station within the allotted time. The winning Qualifier may be awarded the prize subject to verification of eligibility and compliance with the terms of these rules. Station's

decisions as to the administration and operation of the Contest and the selection of the potential winner are final and binding in all matters related to the Contest. The approximate retail value ("ARV") of each Prize is Thirteen Dollars (\$13).

(b) One (1) Grand Prize will be awarded in this Contest. The winner will receive:

A trip for two (2) people (the winner and a guest) to Minneapolis, MN, to include: (i) round-trip coach airfare for winner and one (1) guest from Chicago, IL to Minneapolis, MN; (ii) two (2) nights single-room, double-occupancy hotel accommodations in a hotel in the Minneapolis-St. Paul, MN area as selected by Station; and (iii) two (2) tickets to see George Strait, Chris Stapleton, and Little Big Town at the U.S. Bank Stadium in Minneapolis, MN on November 13, 2021.

The ARV of the Grand Prize is One Thousand Five Hundred Dollars (\$1,500).

TOTAL ARV OF ALL CONTEST PRIZES IS: Two Thousand Forty-Six Dollars (\$2,046).

For entry to the prize event(s), each event attendee may be required to show valid proof of vaccination against the COVID-19 virus and/or valid proof of a negative test for the COVID-19 virus within 72 hours (or such other time as the event organizers require) prior to the event(s).

Should the winner be unable to travel for any reason, winner immediately forfeits the Grand Prize and at that time, Station may select an alternate winner in its sole and exclusive discretion and in compliance with these Contest Rules.

<u>Trip must be taken between November 12, 2021 and November 15, 2021</u>. Travel dates to be mutually agreed upon by winner and Station. Winner and guest must travel on the same itinerary. Winner's guest must be twenty-one (21) years of age or older. If winner elects to partake in any or all portions of winner's Grand Prize with no guest, the Grand Prize will be awarded to winner and any remainder of the Grand Prize will be forfeited and shall not be subject to further or alternative compensation. All elements of the Grand Prize must be redeemed at the same time, and no changes will be permitted after confirmation of any redemption Prize is non-transferable and no substitution will be made except as provided herein in the Station's sole discretion.
