B104'S "TAILGATE N TALLBOYS TICKET BLOW OUT" CONTEST OFFICIAL RULES

The Station will conduct the **B104's "Tailgate n Tallboys Ticket Blow Out"** Contest (the "Contest") substantially as described in these rules, and by participating, each entrant agrees as follows:

1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

Eligibility. <u>Remote Broadcast</u>: Attend a remote broadcast conducted by Station on April 20, 2023 from 6:00pm CT through 8:00pm CT at Gill St. Sports Bar and Restaurant (3002B Gill Street, Bloomington, IL 61704) and complete an entry form. **Limit one (1) entry per person per remote broadcast.** All entries must be received by the deadline stated at the remote broadcast.

- 4. **Winner Selection.** On April 20, 2023 at approximately 6:30pm, 7:00pm, 7:30pm, and 8:00pm CT, Station will select one (1) potential winner each time in a random drawing from among all valid entries received by Station during the Contest Period. The winning entrant must be present to win.
