WBNQ, B104, WJBC, AND NASH ICON'S "SUMMER OF FUN – RILEY GREEN" CONTEST OFFICIAL RULES

The Station will conduct the WBNQ, B104, WJBC, and NASH Icon's "Summer of Fun – Riley Green" Contest (the "Contest") substantially as described in these rules, and by participating, each entrant agrees as follows:

1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

Eligibility. This Contest is open only to legal U.S. residents, excluding dual Florida and New York residents, age twenty one (21) years or older at the time of entry with a valid Social Security number and who reside in the following Illinois counties: Peoria, Woodford, Tazewell, Livingston, McLean, Logan, DeWitt, or Piatt, who have not won a prize from the Station in the last 14 days or a prize valued at \$500 or more in the last 90 days, and whose immediate family members or household members have not won a prize from the Station valued at \$500 or more in the last 90 days Void where prohibited by law.  - (ii) <u>Alternative Method of Entry:</u> To enter a Contest Round without a smart phone, visit the website <u>www.wbwn.com/summer-of-fun-with-bud-light</u> and fully complete the Entry Form. All entries must be received by 11:59pm CT on July 2, 2023.
- 4. **Winner Selection.** On or about 11:00am CT on July 3, 2023, Station will select one (1) potential winner in a random drawing from among all valid entries received by Station during the Contest Period. Each winning entrant will be contacted using the email address and/or telephone number provided with

the entry and may be awarded the prize (subject to verification of eligibility and compliance with the terms of these rules). Station's decisions as to the administration and operation of the Contest and the selection of the potential winner are final and binding in all matters related to the Contest. Failure to respond to the initial verification contact within three (3) days of notification or failure to claim the prize within three (3) days of verification as a winner will result in disqualification and forfeiture of the prize.
