WBNQ, B104, WJBC, AND NASH ICON'S "SUMMER OF FUN – TAILGATE N TALLBOYS SATURDAY" Contest Official Rules

The Station will conduct the **WBNQ**, **B104**, **WJBC**, and **NASH Icon's "Summer of Fun – Tailgate n Tallboys SATURDAY"** Contest (the "Contest") substantially as described in these rules, and by participating, each entrant agrees as follows:

1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

Eligibility. 2. Contest Period. The Contest entry period will begin at 5:50pm CT on June 2, 2023 and will run through 7:59pm CT on June 2, 2023 (the "Contest Period"). The Station's computer is the official time keeping device for this Contest.

3. **How to Enter.**

<u>Remote Broadcast</u>: Attend a remote broadcast conducted by Station on June 9, 2023 from 5:50pm CT through 8:00pm CT at The Station Saloon (1611 Morrissey Dr., Bloomington, IL 61704) and complete an entry form. **Limit one (1) entry per person per remote broadcast.** All entries must be received by the deadline stated at the remote broadcast.

4. **Winner Selection.** On June 9, 2023 every six (6) minutes beginning at 6:06pm CT, Station will select one (1) potential winner in a random drawing among all valid entries received by Station during the Contest Period. The last drawing will be at 8:00pm CT. All winning entrants must be present to win. Each winning entrant will be contacted using the email address and/or telephone number provided with the entry and may be awarded the prize (subject to verification of eligibility and compliance with the terms of these rules). Station's decisions as to the administration and operation of the Contest. Failure to respond to the initial verification contact within three (3) days of notification or failure to claim the prize within three (3) days of verification as a winner will result in disqualification and forfeiture of the prize.

A winner who returns the affidavit of eligibility and liability/publicity release will be deemed to have accepted the contest prize and thereafter will not be permitted to rescind their acceptance of the prize and/or return the prize.
