B104'S "BRETT YOUNG WINSDAY WORKDAY" CONTEST OFFICIAL RULES

A complete copy of these rules can be obtained by contacting radio station WBWN-FM ("Station"), 236 Greenwood Ave., Bloomington, IL 61704, during available business hours Monday through Friday, on the Station website www.wbwn.com, or by sending a self-addressed, stamped envelope to the above address.

The Station will conduct the **B104's "Brett Young Winsday Workday"** Contest (the "Contest") substantially as described in these rules, and by participating, each entrant agrees as follows:

1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

Eligibility. On-Air: Listen to the Station weekdays during the Contest Period during the hours of 9:00am, 10:00am, 11:00am, 12:00pm, and 1:00pm CT, when the station plays the cue to call, listeners should call the Station at 309-821-1041. Caller nine (9) to the Station, as determined by the Station in its sole discretion, will win a prize and will qualify to win the Grand Prize. The Qualifier's name and phone number are subject to verification and compliance with these Contest Rules. All entries may be played on the air. *Time Delay Between Over-the-Air Analog Signal and Internet Broadcast:* Due to the time delay that exists between the Station's analog over-the-air signal and the Station's online webcast, listeners who listen to the Station online may hear the cue to call later than listeners listening to the Station's analog over-the-air signal. As a result, the odds of an online listener entering this Contest on-air may be diminished.

4. **Winner Selection.** On or about 2:40pm CT on September 27, 2023, Station will select one (1) potential winner in a random drawing from among all Qualifiers. The winning entrant may be awarded the prize (subject to verification of eligibility and compliance with the terms of these rules). Station's decisions as to the administration and operation of the Contest and the selection of the potential winner are final and binding in all matters related to the Contest. Failure to respond to the initial verification contact within

three (3) days of notification or failure to claim the prize within three (3) days of verification as a winner will result in disqualification and forfeiture of the prize.

One (1) Grand Prize will be awarded in this Contest. The Grand Prize winner will receive:

- (a) Two (2) tickets to see Brett Young on Thursday, September 28, 2023 at 7:00pm at Braden Auditorium at Illinois State University (399 W. Locust St., Normal, IL 61761).
- (b) Two (2) tickets to the VIP Experience including a pre-concert event to see Brett Young perform acoustic songs and a question and answer session.

The ARV is One Hundred Dollars (\$100).

TOTAL ARV OF ALL CONTEST PRIZES IS: Six Hundred Dollars (\$600).

For entry to the prize event(s), each event attendee may be required to show valid proof of vaccination against the COVID-19 virus and/or valid proof of a negative test for the COVID-19 virus within 72 hours (or such other time as the event organizers require) prior to the event(s).
