B104'S "DWIGHT YOAKAM BIG TICKET THURSDAY" CONTEST OFFICIAL RULES

A complete copy of these rules can be obtained by contacting radio station WBWN-FM ("Station"), 236 Greenwood Ave., Bloomington, IL 61704, during available business hours Monday through Friday, on the Station website www.wbwn.com, or by sending a self-addressed, stamped envelope to the above address.

The Station will conduct the **B104's "Dwight Yoakam Big Ticket Thursday"** Contest (the "Contest") substantially as described in these rules, and by participating, each entrant agrees as follows:

1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

Eligibility. This Contest is open only to legal U.S. residents, excluding dual Florida and New York residents, age twenty one (21) years or older at the time of entry with a valid Social Security number and who reside in the following Illinois counties: Peoria, Woodford, Tazewell, Livingston, McLean, Logan, DeWitt, or Piatt, who have not won a prize from the Station in the last 14 days or a prize valued at \$500 or more in the last 90 days, and whose immediate family members or household members have not won a prize from the Station valued at \$500 or more in the last 90 days Void where prohibited by law. The term "household members" refers to people who share the same residence at least three (3) months out of the year. The Contest is subject to all applicable federal, state and local laws and regulations. Participation constitutes entrant's full and unconditional agreement to these Official Rules and Station's decisions, which are final and binding in all matters related to the Contest. - 2. Contest Period. The Contest entry period will begin at 8:00am CT on November 2, 2023 and will run weekdays from 8:00am until 4:59pm through 4:59pm CT on November 2, 2023 (the "Contest Period"). The Station's computer is the official time keeping device for this Contest.
- 3. How to Enter and Win. Listen to the Station during the Contest Period during the hours of 8:00am, 10:00am, 12:00pm, 2:00pm and 4:00pm CT, when the Station plays sounder (each, the "Sounder"), listeners must call the Station at 309-821-1014. Caller nine (9) to the Station, as determined by the Station in its sole discretion, will be the winner for that Selection Day after providing the Station the winning listener's name and phone number, subject to verification and compliance with these Contest Rules. All entries may be played on the air. <u>Time Delay Between Over-the-Air Analog Signal and Internet Broadcast</u>: Due to the time delay that exists between the Station's analog over-the-air signal and the Station's online webcast, listeners who listen to the Station online may hear the cue to call later than listeners listening to the Station's analog over-the-air signal. As a result, the odds of an online listener entering this Contest on-air may be diminished. Station's decisions as to the administration and operation of the Contest and the selection of the potential winners are final and binding in all matters related to the Contest. Failure to verify winner's eligibility may result in disqualification and forfeiture of the prize. Unclaimed prizes may not be awarded. LIMIT ONE PRIZE PER PERSON.
- 4. **Winner Selection.** On or about 2:40pm CT on September 27, 2023, Station will select one (1) potential winner in a random drawing from among all Qualifiers. The winning entrant may be awarded the prize (subject to verification of eligibility and compliance with the terms of these rules). Station's decisions as

to the administration and operation of the Contest and the selection of the potential winner are final and binding in all matters related to the Contest. Failure to respond to the initial verification contact within three (3) days of notification or failure to claim the prize within three (3) days of verification as a winner will result in disqualification and forfeiture of the prize.

- Verification of Potential Winner. THE ELIGIBILITY OF ALL POTENTIAL CONTEST WINNERS 5. IS SUBJECT TO VERIFICATION BY STATION WHOSE DECISIONS ARE FINAL AND BINDING IN ALL MATTERS RELATED TO THE CONTEST. A winner who returns the affidavit of eligibility and liability/publicity release will be deemed to have accepted the contest prize and thereafter will not be permitted to rescind their acceptance of the prize and/or return the prize. If a potential winner cannot be contacted, fails to sign and return the affidavit of eligibility and/or the liability/publicity release within the required time period (if applicable), or if the prize or prize notification is returned as undeliverable, potential winner forfeits prize. - 8. Entry Conditions and Release.
